Temporarily Closing Certain Township Roads During Winter Months

WHEREAS, the Town Board is the road authority for roads within the Township;

WHEREAS, the Town Board works with limited Road & Bridge funds determined by the levy set by the Town electors at their Annual Meeting to provide for year round maintenance of its roads;

WHEREAS, the Town Board finds that certain roads pose particular winter maintenance problems because of their physical structure, drifting snow, and are especially costly to keep open, especially when special equipment is needed to remove the snow;

WHEREAS, the Town Board determines that these roads are infrequently used and do not provide direct access to homes;

WHEREAS, the Town Board determines that keeping such roads open during the winter months imposes an unreasonable burden on the Town's maintenance funds given their low level of use during the winter months and that they do not provide direct access to homes;

WHEREAS, Town Boards have the authority under Minnesota State Statutes 164.152 and 160.16 to close and barricade Town roads;

NOW, THEREFORE BE IT RESOLVED, by the Town Board of Dead Lake, Ottertail County, Minnesota described on Appendix B shall be closed effective as of the date the Town Board orders barricades and proper signage to be placed on said roads and running until such a time in the spring when the Town Boards determines the roads are sufficiently dry to safely accommodate traffic and orders the barricades and signage removed.

NOW, THEREFORE BE IT FURTHER RESOLVED, that Resolution 05-100-01 and Appendix A are declared revoked by the adoption of Resolution 05-100-02 and the signatures placed below effective immediately.

CERTAIN TOWN ROADS DURING WINTER MONTHS**

WHEREAS, the Town Board is the road authority for town roads in the township;

WHEREAS, the Town Board works with limited road and bridge funds determined by a levy set by the town electors at the annual town meeting to provide for year-round maintenance of its roads;

WHEREAS, the Town Board finds that certain roads pose particular winter maintenance problems because of their physical structure, drifting of snow, and are especially costly to keep open, especially when special equipment is needed to remove the snow;

WHEREAS, the Town Board determines that some or all of these roads are infrequently used and do not provide direct access to homes;

WHEREAS, the Town Board determines keeping such roads open during the winter months imposes an unreasonable burden on the town's maintenance funds given their low level of use during winter months and that they do not provide direct access to homes;

WHEREAS, town boards have the authority under Minn. Stat. §§ 164.152 & 160.16 to close and barricade town roads;

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of Dead Lake Township, Ottertail County, Minnesota that the roads or portions of roads described on the attached **APPENDIX A** shall be closed effective as of the date the Town Board orders barricades and proper signage to be placed on said roads and running until such time in the spring when Town Board determines the roads are sufficiently dry to safely accommodate traffic and orders the barricades and signs removed.
